AVVENTURA TRAVEL SWEEPSTAKES Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: The Avventura Travel Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry and who did not purchase any equipment for purposes of entering the Sweepstakes. <u>Limit</u>: Each entrant may submit six (6) submissions during the Entry Period. Entrants may not enter the Sweepstakes using multiple identities. Multiple entrants are not permitted to share the same e-mail or Social Media Platform account. Any fraudulent acts, including use of any automated system to participate, or other attempts to circumvent these rules are prohibited and will result in disqualification. Administrator is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In

the event of a dispute as to any registration, the authorized account holder of the Social Media Platform account used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned to the Social Media Platform account. Each potential winner may be required to show proof of being the authorized account holder.

- 5. ALL POTENTIAL WINNING ENTRIES ARE SUBJECT TO VERIFICATION BY ADMINISTRATOR, WHOSE DECISIONS ARE FINAL AND BINDING.
